

Beyond Roe: Re-thinking Reproductive Justice in a Changing World

In recognition of the 40th Anniversary of the Supreme Court's decision in *Roe v. Wade*, this conference will bring together scholars, activists, and practitioners to discuss key issues related to reproductive justice and reproductive oppression, looking beyond *Roe* and the abortion issue. Experts will explore what can be learned from previous strategic litigation decisions and the development in the law of reproductive justice, how those lessons effect future advocacy for reproductive justice, both domestically and internationally. Among the issues to be discussed will be the regulation of reproductive justice through statutes, the Constitution, and common law, and how structural inequality and intersectional issues relate to race, economic fragility, immigration status, sexual orientation, and criminal convictions.
