This program will provide the fundamentals of municipal court practice in New Jersey. It is through the municipal courts that most people come into contact with the judicial system, either as a defendant, victim, or witness. Many serious criminal cases, such as robbery, auto theft, or assault, start out as complaints filed in the Municipal Court. Municipal courts are considered courts of limited jurisdiction, having responsibility for motor vehicle and parking tickets, minor criminal-type offenses, municipal ordinance offenses, and other offenses that occur within the boundaries of its municipality. Attorneys will learn about municipal court operations and procedures, common cases, and how to conduct themselves in municipal court.

CLE INFORMATION

Rutgers Law School is an approved New Jersey and Pennsylvania continuing legal education provider. In addition, this program qualifies for New York CLE credit pursuant to the Approved Jurisdiction policy.

NJ CLE Information: This program has been approved by the Board on Continuing Legal Education of the Supreme Court of New Jersey for 4.0 hours of total CLE credit. This program can be used toward the New Jersey newly admitted attorney requirement.

NY CLE Information: This program qualifies for New York CLE credit pursuant to the <u>Approved Jurisdiction Policy</u>. This transitional and non-transitional continuing legal education program qualifies for a maximum of 4.0 credit hours (based on a 50-minute hour), of which an aggregate of 4.0 credit hours can be applied toward the Areas of Professional Practice requirement or the Skills requirement. Duplicate credit for the same hour of instruction is not permitted; an election must be made by the attendee, and each hour may be counted as satisfying only one category of instruction. New York attorneys must view the entire program to receive CLE credit (no partial credit allowed).

PA CLE Information: This program has been approved by the Pennsylvania Continuing Legal Education Board for 3.0 hours of substantive law, practice and procedure CLE credit.

Other Jurisdictions

Rutgers Law School does not seek direct accreditation of live programs or webinars in other states. However, some states allow attorneys to earn credit through reciprocity or self-submission. Attorneys must research CLE rules and request accreditation from their respective state/jurisdiction. Rutgers Law School will provide proof of attendance.
